

INVERT CAN TO USE

DIRECTIONS: FRESH SPILLS: First blot up spill with an absorbent towel-type rag, **INVERT CAN TO USE** then apply **QUICK DRAW** liberally to the spill area. Allow minimal "working" time and blot up with rag.

OLD STAINS: <u>INVERT CAN</u> and apply QUICK DRAW to the stained area and allow three to five minutes for the formulation to penetrate the material. Blot up with towel-type rag. More stubborn blemishes may require mechanical agitation with a soft-bristle brush or repeated applications of the formula. Note: Can must be in the inverted position to discharge product. Failure to operate can in this position will cause discharge of propellent, leaving non-usable, residual product in the can.
